## Eligibility:

To be eligible for the **Industrial Software Corporate Leader of the Year**, the nominated company must:

- Be publicly traded on any global major exchange;
- Have a market capitalization of over \$500 million USD;
- Either of the following:
  - Have a primary focus on operating in industrial markets or offer digital solutions specifically tailored for such markets; or
  - Have a history of partnering and/or collaborating with Digital Industrial tech companies.

### **Evaluation Criteria:**

The Independent Selection Committee will choose the **Industrial Software Corporate Leader of the Year** based on the following:

- Financial performance
- Introduced new approaches, tools, and techniques that have advanced digitalization of industrial sector(s)
- The transformational potential of the software innovation delivered
