- Be an AI-led organization, meaning that the company's core value proposition is driven by Artificial Intelligence

Evaluation Criteria:

The Independent Selection Committee will choose the **Industrial AI Tech Company of the Year** based on the following:

- Unique nature of the solution, its applications, and/or how it impacts its users
- How transformative the software is to its users and how it unlocks new opportunities for user businesses to accelerate
- Financial performance
