- Either:
 - Have a primary focus on operating in industrial markets or offer software solutions specifically tailored for such markets
 - Have a history of partnering and/or collaborating with Industrial Software companies.

Evaluation Criteria:

The Independent Selection Committee will choose the **Industrial Software Index Company of the Year** based on the following:

- Financial & public market performance of their company
- Introduced or acquired new approaches, tools, and techniques that have advanced digital transformation of industrial sector(s)
- The transformational potential of the software innovation delivered
